<b>ELIGIBILITY FOR TIME RECOGNITION TO THE SWIMS DATABASE</b>	<b>Effective September 1, 2022</b> , there will <b>NO</b> longer be a 30-day administrative grace period. Going forward, ANY athlete who has not completed the APT requirements by their 18 <sup>th</sup> birthday <b>WILL NOT</b> be a USA Swimming member in good standing unless or until the APT requirement is completed. This includes eligibility to compete in USA Swimming sanctioned meets, club practices and all other related activities. Athletes will continue to receive an email notification reminder of the APT requirement 30 days prior to their 18 <sup>th</sup> birthday as well as a reminder on their 18 <sup>th</sup> birthday. ALL I+USA Swimming members aged 18 years old and older are required to complete APT annually. This is the individual's responsibility and includes both athlete and non-athlete members.

	<p>This facility seats 1,900 and contains both a competition pool and diving well. The competition pool is 50 meters by 10 lanes, with two movable bulkheads so that courses can be set up for 25 yards or 25 meters. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming &amp; Georgia Swimming. The water depth of the pool is 9 1/2 feet at start end and 9 1/2 feet at turn end. (Measured from 3' 3 1/2" (1.0 mtr) to 16'5" (5mtrs) from both end walls).</p>
<b>MEDICAL SUPERVISION:</b>	Lifeguards, AED, and Athletic Trainer will be available to athletes in the meet.

<b>ELIGIBILITY:</b>	<p>Invitational</p> <p>This meet will be conducted as defined above. All 2024 swimmers registered with USA Swimming and/or their respective World Aquatics Federation, in good standing with their local national federation, will be allowed to compete.</p> <p>All foreign delegations must submit documentation from their federation indicating athletes, coaches, and team support are members in good standing of their World-Aquatics-affiliated federation. "Host Club" will not allow unregistered swimmers, coaches, officials, or teams to participate in this meet. No swimmer will be permitted to compete unless the swimmer is a member as provided in Article 302.</p>
<b>ENTRIES:</b>	<ul style="list-style-type: none"> <li>● This meet will not be pre-seeded.</li> <li>● Swimmers may swim a maximum of (3) individual events per day. Deck entries can be made with the clerk of course up to 30 minutes before the start of the session.</li> <li>● Any swimmer who has one or more qualifying standards may enter up to two (2) Bonus events total.</li> </ul>

<b>CHECK IN:</b>  <b>CLERK of COURSE:</b>	<ul style="list-style-type: none"> <li>• 1500 Positive Check-In or Scratches must be completed by 3:30 pm Wednesday in person or via email to <a href="mailto:ced7946@yahoo.com">ced7946@yahoo.com</a> in order to be seeded.</li> <li>• We ask all coaches and/or athletes to declare any scratches pursuant scratch deadlines day prior to Prelims on Wednesday through Friday to insure full heats and the best competition opportunities.</li> <li>• Positive check-in is required for the 800 free by 10:00am on Saturday.</li> <li>• Swimmers must sign up for Time Trial events with the Clerk of Course by 10 am – Thursday, Friday, and Saturday.</li> </ul>
<b>ENTRY SUBMISSION:</b>	<p><b>Submit one check payable to: SwimAtlanta</b>  <b>Entries must be received on or before: May 3, 2024</b></p> <p>Submit entries using Hy-Tek team manager. Entries must include the USA Swimming Club Code and each swimmer's USA Swimming number, first and last name, age, and seeding time for each event entered.</p>
<b>Doping Control:</b>	<p>This event is subject to testing under USADA and AQUA rules.  <b>ALL ATHLETES are subject to testing.</b>  Please note that all minors must have a representative with them.  NCAA doping control rules are different than the rules for this meet. Please be sure all of your athletes have checked their meds with USADA.</p>
<b>RULES:</b>	<p><b>Current USA Swimming Rules will govern this meet.</b></p> <p><b><u><a href="#">Tech Suit Restrictions for 12-and-Under Swimmers</a></u></b>  (Note: WOVEN FABRIC-A suit with woven fabric and sewn seams that does not extend below the hips is permitted.)  (Note: KNIT FABRIC-A suit with knit fabric and sewn seams not extending below the knees is permitted.)  This rule is in effect for all USA Swimming competitions in the United States, so any manufacturer or vendor selling a suit in the United States is subject to the above rule. No Technical Suits may be worn by any 12-Under USA Swimming athlete member in competition at any Sanctioned, Approved or Observed meet.</p> <p>Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, behind the blocks (Including warm-up, warm-down, and Competition), rest rooms or locker rooms.</p> <p>Any swimmer entered in the meet, must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.</p> <p><b>Deck changes are prohibited.</b> (Defined as changing, in whole or in part, into or out of a swimsuit when wearing just one suit in an area other than a permanent or temporary locker room, bathroom, changing room or other space designated for changing purposes).</p>

	<p>Swimmers participating in deck changing could be subject to removal from further competition in the meet.</p> <p>On deck registrations will not be permitted during this event.</p> <p>Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coaches' areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and /or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair, Program &amp; Events Committee Chair, or designee.</p> <p>All referees, starters, administrative officials, chief judges, and stroke and turn judges, serving in an official capacity in a sanctioned event, must be non-athlete members of USA Swimming or members of other World Aquatics-member organizations. All meet directors for meets sanctioned by USA Swimming must be members of USA Swimming. Except for coaches accompanying athletes participating under the provisions of 202.9 or USA Swimming's "open border" policy, all persons acting in any coaching capacity in a sanctioned event must be coach members of USA Swimming.</p> <p>Photos and videos may be taken of swimmers during the meet by parents or a professional photographer retained by the host club. All participants agree to be filmed or photographed by photographers designated by the meet host and to allow the meet host the right to use names, pictures, likenesses, and biographical information before, during, or after the period of participation in Georgia Swimming competitions to promote swimming and meets hosted by the meet organizer. If you do not wish to have your child(ren) photographed, you may withdraw your consent by informing the Meet Director before the start of the first day of the meet.</p> <p>Swimmers participating under the provisions of 202.9 or USA Swimming's "open border" policy must be under the supervision of their own coach or a USA Swimming member coach. The Meet Director or Meet Referee may assist the swimmer in deciding for such supervision, but it is the swimmer's responsibility to make such arrangements prior to the start of the meet.</p>
<p><b>USA SWIMMING MEMBER VERIFICATION:</b></p>	<p><b>As of September 2022, Deck Pass and Deck Pass Plus are no longer available.</b> To access USA Swimming member benefits, including your USA Swimming member card, download the USA Swimming app. Present this card to verify your USA-S and GA LSC credentials are in good standing.</p>
<p><b>COACHES:</b> <b>COACHES MEETING:</b></p>	<p>Coaches will be required to sign in at the Clerk of Course desk to verify their credentials, via SWIMS 3.0, are in good standing with USA-S and their respective LSC. Coaches Meeting will be held via conference call the week of the event; details to follow.</p>
<p><b>OFFICIALS:</b></p>	<p>"Host Club" welcomes visiting officials and apprentices and will appreciate help in officiating this competition. There will be an official's meeting 1 hour prior to the start of each session. The official's uniform will consist of a white polo collared shirt, navy blue shorts, skirts or slacks with white socks and white shoes. All officials must present at check in, their current LSC Officials Certification Card; <b>OR</b> a recently completed Apprentice Form; <b>AND</b> proof of current USA Swimming Non-Athlete membership. Credentials may be required for deck access and hospitality.</p>

<b>MEET COMMITTEE / MEET JURY:</b>	The Meet Committee / Meet Jury shall be established during the coaching meeting or prior to the competition and shall consist of the Meet Director, Meet Referee, 2 Coaches, and 1 athlete member, as appropriate. As defined in the Official Glossary (2024 USA Swimming Rulebook)
<b>AWARDS:</b>	Prize money will be awarded by USA Swimming for each individual Olympic event from the <b>combined</b> 2024 Club Excellence Challenge Series competition results according to the following: 1 <sup>st</sup> Place - \$1,500 2 <sup>nd</sup> Place - \$1,000 3 <sup>rd</sup> Place - \$500
<b>SCORING:</b>	No team scores will be kept at this event
<b>CONCESSIONS:</b>	Concessions will be located upstairs in the café
<b>GEORGIA WARM-UP POLICY:</b>	The <a href="#">Georgia Swimming approved warm-up guidelines</a> will be followed for this meet. Warm-up lane assignments will be posted at the pool. USA Swimming Certified Coaches must supervise in the vicinity of all warm-up activities.
